Services

Provider agrees to transport and provide clean, groomed Highland cattle for a scheduled appearance at the event. Providers will clean up droppings from cattle and maintain a clean area where cattle are located at event. Provider retains sole ownership, custody, and control of the animals at all times.

Client Responsibilities

Client agrees to:

- Ensure the venue has approved the animals.
- Provide a safe, level, and accessible location for the animals and trailer.
- Ensure guests follow all instructions given by Provider.
- Not permit anyone to feed, lead, or handle the animals unless expressly authorized by Provider.
- Keep children supervised at all times around the animals.

Animal Welfare

Provider may remove the animals immediately if weather, noise, crowd behavior, unsafe conditions, illness, or any circumstance threatens the health or welfare of the animals or people. No refund shall be required if removal is necessary for safety or animal welfare.

Assumption of Risk

Client understands that livestock are unpredictable and that interaction with animals carries inherent risks, including injury, property damage, or death. Client voluntarily assumes these risks for themselves and their guests.

Release and Hold Harmless

To the fullest extent permitted by law, Client releases, waives, and agrees to hold harmless Provider, its owners, employees, volunteers, and agents from any claims, demands, damages, or liabilities arising out of the animals' presence at the event, except to the extent caused by Provider's gross negligence or willful misconduct.

Property Damage

Client accepts responsibility for damage caused by guests or unsafe conditions under Client's control. Provider is not responsible for damage resulting from normal livestock behavior unless caused by Provider's negligence.

Cancellation Policy:

Deposit/Retainer is non-refundable if Client cancels 30 days or less before the event. If Provider needs to cancel due to animal illness, injury, unsafe transportation conditions, or another emergency, Provider will give full refund of all amounts paid.

This booking is contingent upon Provider receiving written approval from the event venue. If the venue declines to permit livestock or refuses to execute Provider's required venue agreement, Provider may cancel the booking and refund all amounts paid, less any non-refundable administrative fee, unless an alternate approved venue is arranged.

Governing Law

This Agreement shall be governed by the laws of the state in which the event occurs.
